Since 2008, headquartered in Dumfries, VA, the government has awarded AMSG **more than 60 government contracts** supporting 18 Program Offices at multiple federal agencies; 11 programs at Veterans Affairs; and 23 contracts supporting military commands at USMC, US Army, US Navy, and the Defense Health Agency. We also currently contract with the Department of Defense (DoD), Department of Homeland Security (DHS), Department of Energy (DOE), Veterans Affairs (VA), and Federal Trade Commission (FTC).

AMSG **operates three business units**, specializing in Technology, Information & Knowledge Management, Mission Support & Operations, and Financial Support Services.

With year-over-year growth, **we have primed 73% of the contracts** we support with more than \$192 million in projects across DHS, Army TRADOC, DHA and more.

Over the past 15 years, our teams have supported 41 Defense and federal organizations at 100 military and federal installations, across 20 states, supporting more than **19 million end-users**.
